

Dear Requester,

Thank you for your recent Freedom of Information Request.

I am now able to provide you with the information supplied by the relevant department, as follows:

Number (WTE) of health visitors (SCPHN) and school nurses (SCPHN) and the skill mix involved.

The commissioned service is integrated across the 0 to 19 age range, and teams are skill mixed. NCC do not hold accurate details of workforce establishment against agenda for change banding, an FOI request would need to be addressed to the provider of this service, Nottinghamshire Healthcare NHS Foundation Trust, to obtain this information.

The planned establishment across the whole service in 2018-19 is 255.49 WTE. This includes skill mixed teams, the Family Nurse Partnership and NCMP.

Their caseload ratio? Do you work to the national recommended amount? (was around 250)

NCC do not hold detail in relation to the caseload numbers or ratio's, an FOI request would need to be addressed to the provider of this service to obtain this information.

Average number of children on caseloads for 0-5 and 5-19 per SCPHN?

NCC do not hold detail in relation to caseload numbers or ratio's, an FOI request would need to be addressed to the provider of this service to obtain this information.

Time spent on safeguarding including, TAF, S17 and S47 for 0-19. Any particular position statement on school nurses contribution towards safeguarding?

NCC do not hold detail in relation to time spent on this activity. The service delivers care in line with Healthy Child Programme four levels of intervention: universal, universal plus, universal partnership plus and safeguarding. For 5-19's, where there are identified public health needs, SPHP's and the wider Healthy Family Team have a key safeguarding role.

What other Public Health work do HV and SN undertake? (exc. NCMP and 5 mandated reviews)

SPHP's, and the skill mixed team, deliver:

- nine universal reviews/contacts in line with the Healthy Child Programme, widely promoted via a core offer and supported by universal access to advice and support,
- four levels of provision, based on need and delivered in line with the Healthy Child Programme, with safeguarding at the core,
- targeted support and evidence based level one interventions, focused on high impact areas,
- health promotion across the life-course.

Do the Councils Childrens Service make any financial contributions to these services?

Children's services do not currently contribute financially to this contract.

What is the annual budget for the 0-19 Public Health Nursing Service?

The 2018/19 budget is £13,851,049. Please note this includes the Family Nurse Partnership and NCMP.

What was the budget for the 0-19 Public Health Nursing Service in previous years?

The budget in 2017/18 was £14,208,321. Please note this includes the Family Nurse Partnership and NCMP.
