Further to your enquiry of 08.11.2018 regarding monitoring arrangements for Sutherland House, We have reviewed the correspondence that you have received from the Local Authority and must firstly apologise that you have been given what appears to be contradictory information.

Sutherland House is an Independent Non-Maintained School which means that it does not have any formal reporting relationship to any Local Authority although the established protocol we have with neighbouring Local Authorities is that the home Authority where the setting is based (in this case Nottingham City) would take the lead if there are major issues to be addressed. You are, however, absolutely correct that Nottinghamshire County Council places a significant number of children at Sutherland House and must therefore ensure that appropriate education provision in place and that the school discharges its delegated duty to conduct annual reviews on behalf of the Local Authority.

The mechanism through which we do this is through termly review meetings where any concerns regarding individual learners should be discussed alongside any more general issues. We can confirm that such meetings have taken place following the establishment of ICDS in 2016 but due to staff changers there has not been the continuity of contact with Sutherland House that we would have wished nor has the recoding of such meetings met the standard that we as a Local Authority, or you as a tax payer and parent, could reasonably expect and we apologise for this. We can advise that the ICDS Assessment Team do have a Snr link officer for Sutherland House, with direct oversight of the ICDS Manager. This officer attends on Sutherland House on a termly basis to complete monitoring and ensure that the local authority have an overview of pupils progress. Additionally we can advise that where it is identified as necessary an ICDS officer will attend individual pupils EHC reviews.
