IMPORTANT – PATIENT SAFETY

Please check that you are using the most recent copy (live version) of the Nottinghamshire County Council standardised NHS Health Check protocol /template as this will ensure that the correct READ codes are being used. This is essential to ensure that national safety guidelines are adhered to.

SystmOne practices: For all **Greater Notts** practices, this protocol/template can be found in the F12 Data Entry template and the protocol/template is entitled NHS Health Check 2019.

Bassetlaw and Mid-Notts practices can either add to the toolbar or use the F12 launcher in SystmOne and search for the health check protocol/template

(the protocol/template is indicated by the blue 🙏 symbol).

EMIS practices: the template is now being shared and updated via the Resource Publisher. Instructions for updating the template have been sent to all EMIS practices. If you have NOT activated Resource Publisher, please contact the F12 team (email: ruccg.f12.pathways@nhs.net) as soon as possible to get setup

DEMENTIA

Everyone who has an NHS Health Check should be made aware that the risk factors for cardiovascular disease are the same as those for dementia. This can be as simple as letting individuals know that "what is good for the heart is good for the brain".

In addition to letting people know that the risk factors are the same, **everyone aged 65-74** who has an NHS Health Check should be made aware of the signs and symptoms of dementia and be signposted to memory services if appropriate.

Please ensure that you tick the box for Dementia Awareness in the NHS Health Check protocol/template to indicate that this has been done.

E-CIGARETTES

PHE advice on recording e-cigarettes use is:

Scenario	Qrisk option
Vaper only(no history of smoking)	Non-smoker
Vaper and ex-smoker	Ex-smoker
Vaper and still smoking	Record based on number of cigarettes smoked

INELIGIBLE NHS HEALTH CHECKS

The NHS Health Check protocol/template should NOT be used for any other patient checks (eg CVD annual reviews, Health MOTs, Well Man/Woman checks, new patient checks, etc).

If the patient is not aged 40-74 years and/or already has any CVD-related conditions, or has had an NHS Health Check within the last 5 years, then these checks will be classed as "Ineligible" and will not be paid for.

Opportunistic NHS Health Checks: please ensure that a patient is eligible before proceeding.

An alert will appear on launching the NHS Health Check protocol/template if the patient is not eligible and the NHS Health Check protocol/template should not be used for these patients.
