I am writing to you in reply to your Freedom of Information Act (FOIA) request to Nottinghamshire County Council. I have the following information.

*Is there a framework in place for the provision of Supported Living for adults with Learning Disabilities / Autism, Mental Health, Complex Needs, Forensic / Risk of Offending, etc?*

There is a multi provider agreement in place for the provision of Care Support and Enablement for Younger Adults with Disabilities and/or Complex Needs. This agreement has two separate Lots.

However, this is not the main way the Council procures services for this group of people as there is currently a core provider model in place for Care, Support and Enablement packages. There are 4 core providers (Area 1: Newark and Sherwood Area 2: Bassetlaw Area 3: Mansfield and Ashfield and Area 4: Broxtowe, Gedling and Rushcliffe).

These providers are contracted to pick up all current packages for Adults aged 18-64 at the time of referral. However, if they are unable to do so, under specific circumstances the Multi-Provider Agreement can be used.

*If so, can I have a list of all providers who are on this framework?*

*When do the contracts run out for these providers?*

The provider agreement runs until 2022.

*When is the next tender process for Supported Living or equivalent going to begin?*

It is open year-round but closes 4 times a year for marking. Providers who were unsuccessful the first time they applied can resubmit an application.

*Which individual is responsible for sourcing properties for Supported Living?*

The Commissioning Officer for this area is Mercy Lett-Charnock, who works in Adult Social Care and Health.
