THE NOTTINGHAMSHIRE COUNTY COUNCIL (CARLTON CONSOLIDATION AREA  
5) (MAPPERLEY PLAINS AREA) (AMENDMENT NO. 1) (GRETTON  
ROAD/BONINGTON ROAD) TRAFFIC REGULATION ORDER 1992 (7003)

The Council of the County of Nottinghamshire ("the Council") in exercise of its powers under Section 1(1) and (2), 2(1) to (3), 4(2) and Part IV of Schedule 9 of the Road the Road Traffic Regulation Act 1984 ("the Act"), and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:-

COMMENCEMENT

1. This Order shall come into force for all purposes on the 14<sup>TH</sup> day of DECEMBER 1992 and may be cited as "The Nottinghamshire County Council (Carlton Consolidation Area 5) (Mapperley Plains Area) (Amendment No. 1) (Gretton Road/Bonington Road) Traffic Regulation Order 1992".
2. "The Nottinghamshire County Council (Carlton Consolidation Area 5) (Mapperley Plains Area) Traffic Regulation Order 1991" hereinafter referred to as "the 1991 Order" shall be amended as follows:-

Schedule 3 to Part I of the 1991 Order shall be deleted and in its place shall appear the Schedule headed "Part I Schedule 3" which is contained in this present Order.
