Dear Requester,

Further to your recent request for information, the below statement had been received from the department.

From the reports we hold this is not something we would be able to extract. It may be easier if the individual local councils are contacted to advise on this.

We do not divide up and hold the categories of what each adaptation is for, so this would not be something we could provide to the requester.

As we have a large waiting list it is impossible to advise on how many bathrooms we may have waiting, as again we do not hold in individual categories and to look at each individual would take us over the threshold of cost. Our children's' cases are often complex so may involve a variety of needs within any one adaptation.
