I am writing to you in reply to your Freedom of Information Act (FOIA) request to Nottinghamshire County Council about direct payments. I have the following information.

*Is there a social care transformation manager or personalisation lead or similar role? If yes please provide name(s), email(s) and telephone number(s).*

N/A

*How many direct payments do you currently have in place for children and young people?*

597 direct payments (106 of which are pending, either waiting for paperwork to be returned, waiting for pre-payment cards to be ordered/created or waiting for vendor accounts to be created).

*Of these, how many are managed accounts, how many are paid into bank accounts and how many are paid onto pre-paid cards?*

Managed Accounts: 5

Bank Accounts: 180

Pre-Payment Card: 306

*How many direct payments do you currently have in place for adults?*

2636 (as of 1st June 2019) had a regular DP with 276 receiving a one-off DP.

*Of these, how many are managed accounts, how many are paid into bank accounts and how many are paid onto pre-paid cards?*

893 people in receipt of a third-party managed account, 756 people are in receipt of a pre-paid card and 987 people were using a separate bank account to manage their DP.

Approximately £26,000 per annum.

There are currently three Accredited Providers: People Plus, Penderels and Solo (we do not have figures for people getting payroll support from non-accredited providers).

*If the service is provided by a third-party organisation what is the annual cost to the Local Authority?*

For the 3 accredited providers the annual cost to the authority is £172,618

*Do you provide an in-house managed account service?*

At present no, but it is something that is being considered.
