Further to your recent request for information under the freedom of information act.

Nottinghamshire County Council are only able to provide responses to Q2 and Q7 and Q8 where they apply to the Q2 cohort. Answers to the other questions are not recorded in a easily accessible format and would require a manual review of each file, estimated at 20-30 mins per file. This would not guarantee an answer was recorded but would take us well over the threshold allowed under the Act and so we are exempting in this case under s12.

We've also only been able to provide by financial year, not calendar year due to how the data is held.
