Thank you for your request for information relating to Capital Programme budget for each of the last 5 (five) full financial years. I can now let you have the following information in response to the questions you raised.

i) in the Newark and Sherwood District Council area, and

ii) in the Town of Southwell (which may already be defined by you as the relevant local highway authority, but, if not, should be taken to mean any activity/scheme from the above list which has been affected within a one-mile wide radius centred from Southwell Minster - please say which 'definition' you have used when responding).

Expenditure is not currently coded at a district or town level and to investigate and break down the expenditure to either of these levels would far exceed the Fees and Appropriate Limit Regulations and currently stands at 2.5 days or 18 hours. We estimate that it will take one officer in excess of 2.5 days to locate the information you have requested. Under Section 12 of the Freedom of Information Act we are not obliged to process requests that exceed this limit.

In 2018/19 there are 1,156 lines of expenditure for the integrated transport block alone (the maintenance block will have twice as many lines as this as it has a greater budget allocation). A

conservative estimate is that this would take a couple of minutes per line (it will likely take longer) to determine the town/district. The estimated time it would take to investigate just the 2018/19 integrated transport block expenditure is therefore 39 hours.
