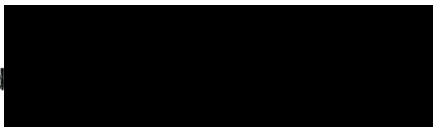
Upgrading from a footpath to a bridleway the route known as Hockerton FP4a at SK696580 to the end of Hockerton BW4 at SK697582.

Upgrading from a footpath to a bridleway the route known as Hockerton FP6 at SK693586 to the end of Hockerton BW8 at SK692587.

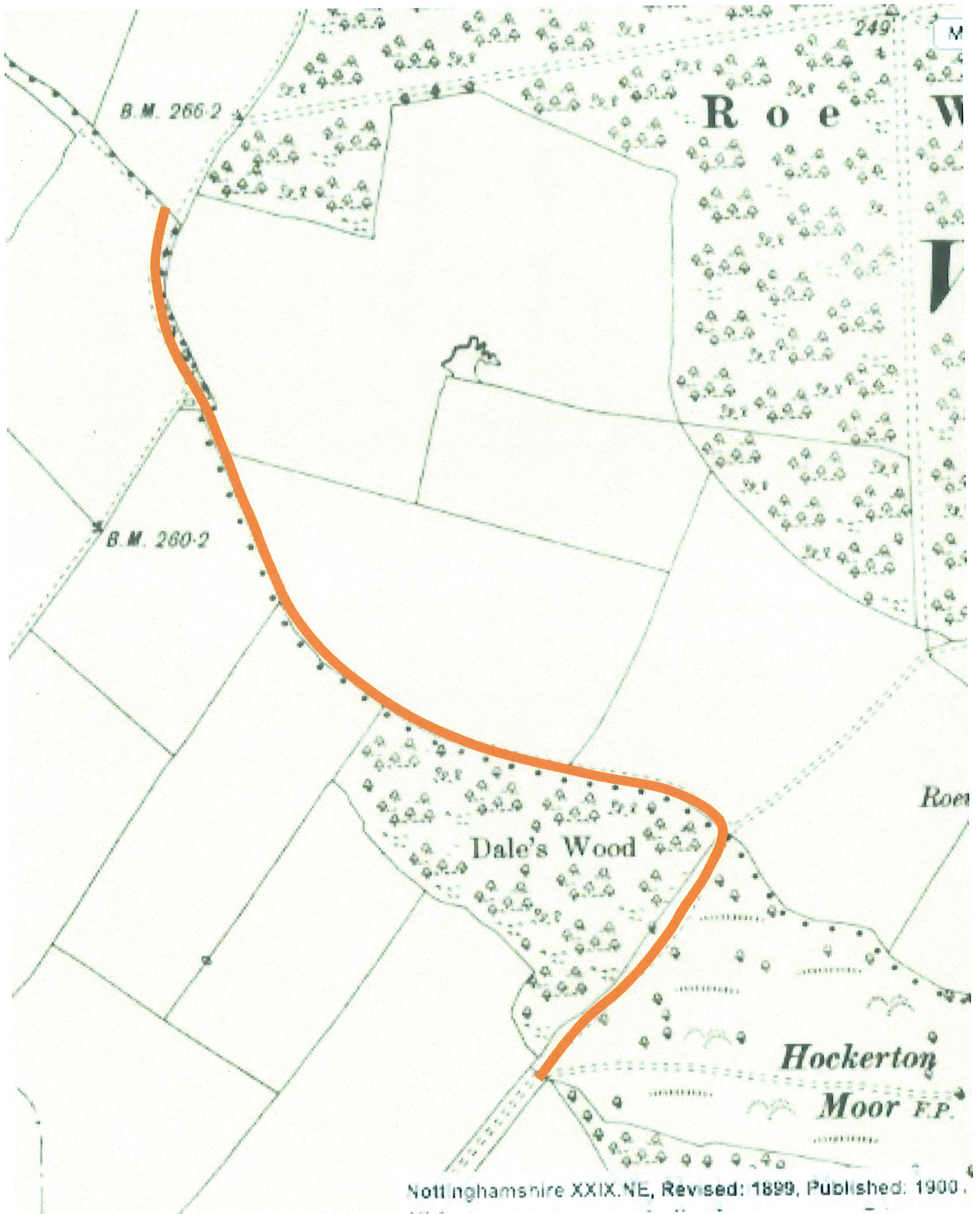


