and shown on the attached map

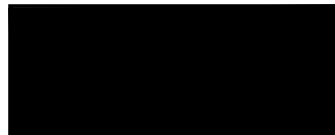

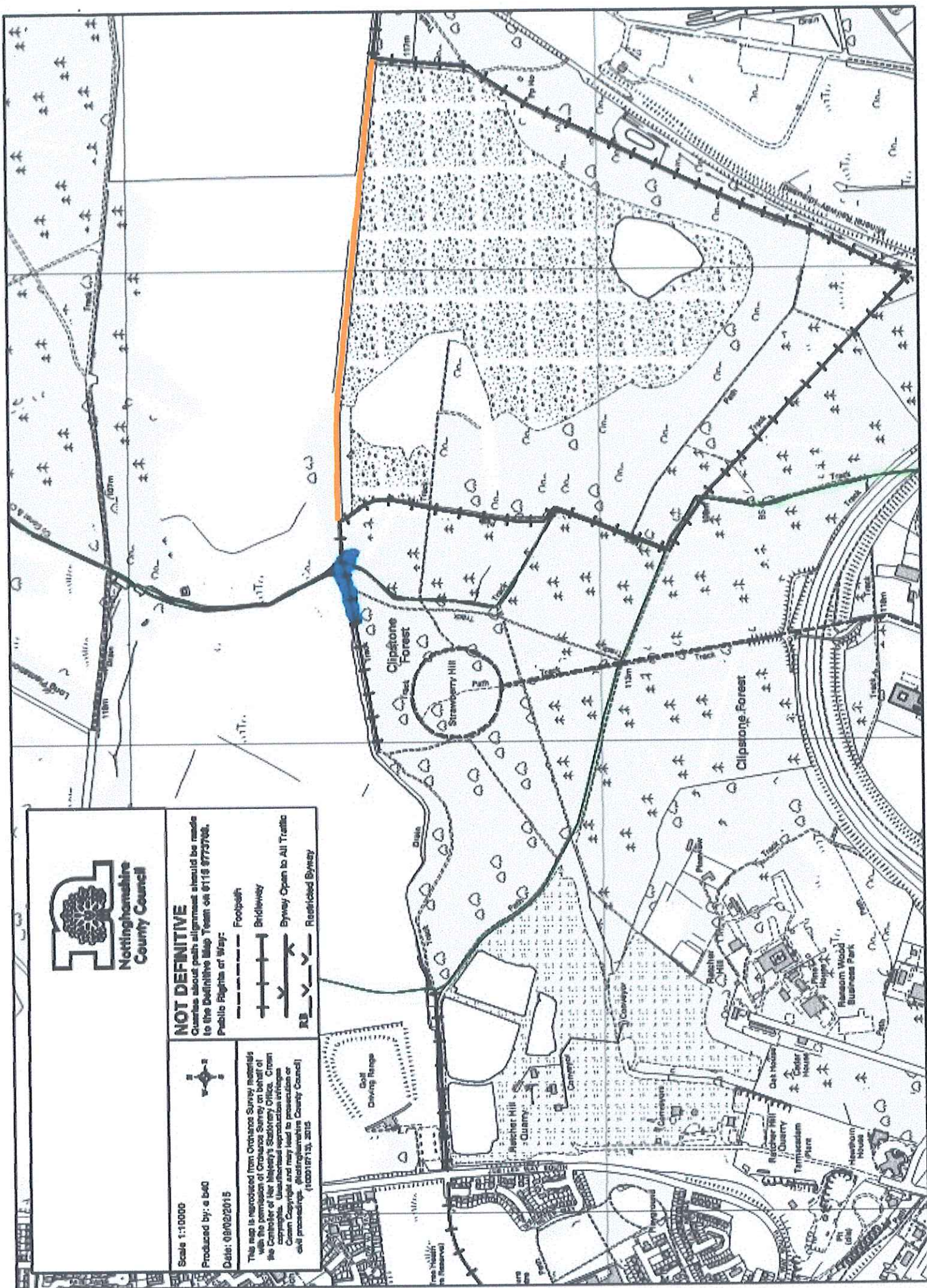
