

**NCC-040812-19 mental health provision for vulnerable groups of children and young people**

Dear Requester,

Further to your request for information under the freedom of information act, please see below in response. Please accept our sincere apologies for the delay in providing this within the recommended time under the act. Nottinghamshire County Council takes its responsibility under the act seriously and have in this case failed to meet this and we are taking this matter seriously and looking into ways to improve.

1. What specific provision is available in your area for children and young people diagnosed with conduct disorder and those with conduct difficulties? Please list specific services and tiers they fall under (e.g. Tier 2 or targeted; Tier 3 or community specialist or Tier 4 or inpatient). Please do not include general CAMHS services that are not specifically tailored to children with conduct disorder.

Conduct is a broad statement however – we would want to understand from whom they have this diagnosis in the first place and why they couldn't also provide support?

CAMHS CLA would support if a child was LAC or adopted and then it would be the CAMHS SW team if they are a SGO/Kinship etc.

CAMHS CLA are tier

If the children are not LAC it would be community paediatrician or referral via SPA to see if core CAMHS/CAMHS ID could support.
