There have been minimal changes to the domestic abuse budget over the last 5 years.

In 2015/16 budget envelope was reduced by £60,000

In 2017/18 budget envelope was reduced by £37,179

In 2018/19 additional funding from NCC for two years to deliver Children Affected by Domestic Abuse work increase £115,000

In 2019/20 funding for the IOM IDVA ends.
