I am writing to you in reply to your Freedom of Information Act (FOIA) request to Nottinghamshire County Council. I have the following information.

1. In the 2018/19 academic year, how many families received a letter from a school in respect of their child's attendance, including a warning that if attendance did not improve they may be at risk of prosecution?

Not available - the local authority does not collate data about all the correspondence schools send to parents in respect of a child's attendance.

- 2. In the 2018/19 academic year, how many families were referred to Education Welfare (or an equivalent service) in respect of a child's school attendance?
- 625 referrals were received during 2018-2019 where school attendance was an issue. Of these we commenced the legal process in about 360 instances.
- 3. In the 2018/19 academic year, how many families were prosecuted in respect of a child's school attendance?
- 158 parents were prosecuted through the Magistrate court in 2018-19 in respect of the child's school attendance.
- 4. How many of the prosecutions at (3) resulted in (a) parents being fined, (b) a non-custodial sentence, (c) a custodial sentence, (d) no action being taken against the parents?

a) Parents being fined -	76
b) A non-Custodial Sentence	58
c) A Custodial Sentence	1
d) No Further action being taken*	22

^{*}We are interpreting this to include cases where the parent was found guilty but no additional penalty was given.

Please note:

Some parents will have received a combination of a fine and community sentence.

The figures above do not include parents who have been referred to the Magistrates Court under the Single Justice Process following non-payment of an Education Penalty Notice Fine.

- 5. Does the Council collate any statistics in respect of whether:
- a) the children involved in the above situations have an EHC Plan, are the subject of a current or previous request for an EHC Needs Assessment, or are known to CAMHS or equivalent? No; we do not collate aggregated data of this kind, although it may be included in the case file.
- b) the parents involved in the above situations have any disability?

If so, please provide a copy of these statistics in respect of the 2018/19 academic year. If not, please explain whether the Council has any policy to ensure its actions in respect of school attendance do not discriminate against families where there is a disability or additional needs and please provide a copy of any such policy, guidelines or similar.

No; we do not collate aggregated data of this kind. Where this is relevant to the case then it will be included within individual case files and records.

The council has a policy in relation to enforcement action (attached). This also covers cases open to our Youth Justice Service.
