

KECEP BY:

I used this path the first time about 1983. My parents in law had moved to Farndon and we had a day out walking around Newark Wharf and down the Trent past the old bonded warehouses and maltings. I went back on my own a few weeks later and walked from the cattle market car park across Kelham Island to Kelham Hall using the footpath near the rugby ground. On the way back I used Kelham Lane. It was an open lane from one end to the other with views across to the Newark Castle. This was before the new road was constructed.

When I started making Rights of Way applications I thought about this route. In about 2010 I was driving past the Kelham end with my bike in the back of the car so stopped and cycled the lane to the other end and back. The main changes were the addition of the metal gates at either end, but these didn't stop access as they had gaps at the side. I have been back with my bike about every 2 years since. In April 2016 I had started to gather documentary evidence intending to make an application for a Definitive Map Modification order so took the camera and photographed the route. There were still gaps at the side of the gates at that stage and the concrete blocks at the Newark end had appeared. Sometime between then and 2019 another gate had been installed on the southern side of the lane at the Kelham end and bars welded between this and the existing gate and on the other side of that gate up to the hedge, effectively blocking access.

I don't remember prohibition signs the first time I walked it and there were certainly none from 2010 onwards. Nothing has stuck in my memory about users from the first time, but since 2010 I have seen the odd dog walker on most occasions. One time there where was a group of people walking it towards Kelham Bridge.
