Thank you for your request for information relating to the provision of Carers Grants and assessments, within Adult Social Care. I can now let you have the following information in response to the questions you raised.

What is the current process for carers completing a carer's assessment? Details of how to request a carers assessment and the process for doing so are available on the Nottinghamshire County Council website

Is there the ability for carers to do/request this online? Yes, the option to complete a carer's assessment online is available and will be offered by the Customer Service Centre or the Adult Access Team depending who is in contact with the carer concerned.

Do you offer carer's grants? If so, what are the eligibility criteria? No Nottinghamshire County Council do not currently offer carer's grants. However, Carers Trust East Midlands who are commissioned by Nottinghamshire County Council to provide the Carers Hub service on the Council's behalf do have access to a grants fund.

If you do not provide grants, is provision for carer's wellbeing available as a direct payment if eligible for support? Yes, a direct payment can be made. This is dependent on the eligibility criteria being met and either a payment of £150.00 or £200.00 can be made in a financial year depending on the level of impact of the caring role. Additionally, tailored personal budgets can be provided dependent on need. Increasingly direct payments are becoming needs based as part of the personalised approach to social care and as such we no longer offer a grants allocation system.

Are there plans to review / change the policy for provision of carer's grants and/or direct payments? If so what are these plans? Yes, there will be a new Carers Support Offer implemented later this financial year (2019/2020). The revised offer will encompass changes to both the Council's assessment and support planning processes as well as its commissioned information, advice and support services. These changes are the result of feedback from carers, the outcome from consultation and development work with a group of carers and will improve the early response offer to carers and provide greater opportunities for information, advice and support as required. The automatic direct payment of £150 / £200 will be removed however; these payments will be provided to individuals where this is the best option, with increased

scope to provide higher direct payments to those carers who have an identified, specific need for services or equipment to promote their wellbeing or enable them to continue caring.
