There is no internal appeal process once the Council has made a decision on liability. The next course of action for claimants is to seek legal advice and take their claims through the litigation

process. Only two of the claims detailed in the table above were litigated, both in 2019. In both cases the court upheld the Council's decision to deny liability and repudiate the claims.
