As the information is changing on a day by day basis, this guidance will be updated regularly at 3pm every day. It is also recommended that, for this reason, information is not printed off and given to staff as a hard copy as it is likely to become outdated within 48 hours.

The national guidance for care settings has not changed since February and there remains a moderate risk in the UK. There has been an increase in cases of COVID-19 in the UK and small numbers reported in Nottinghamshire.

## Message from the Adult Social Care and Health Department: as at 12th March 2020

- The current position is that we are in the Business as Usual phase of our Emergency Plan. This means that we are continuing to work as normal and making sure that staff have good information.
- We are following Public Health England advice in that hand washing with soap for at least 20 seconds is the most effective way to kill germs and our advice to providers is to do the same
- We are keeping in regular contact with our external social care providers
- We will continue to support providers with their Emergency Business Continuity Plans
- We are minded about cashflow and how we pay contracted providers and will be putting
  in measures to ensure that they continue to be paid promptly and that we maintain
  stability in the local care market
- We are also making information available to external providers and personal assistants who do not ordinarily work with the Council and will support as necessary

 We will ensure that we adapt and update our plans as necessary following Public Health England Guidance (PHE)

## **PPE** equipment

The advice is not to stock pile PPE equipment.

There is still no need for staff or visitors to wear masks as a precaution, these do not provide full protection and the guidance remains that increased hand washing and cleaning and disinfecting frequently touched objects and surfaces offers the best prevention.

# Support with contingency planning and what you can do

The Quality and Market Management team are already in the process of contacting all externally contracted providers over the coming days to discuss the arrangements you are making locally to respond to the COVID-19 outbreak in order to assess the key market risks and direct the support the Council can provide.

Some of the things we are asking you to consider include:

- Make sure your staff members are supported to understand the situation and provide good guidance
- Make sure you have up to date information on the needs of people you support, their family or local networks and their individual needs and risks.
- RAG rate your service users to understand where care delivery is critical and to inform your service continuity plans
- Have you considered whether services can be delivered in other ways if necessary and to whom (for example wellbeing phone calls rather than actual visits for some community based services)?
- Do you have a full understanding of how staff availability is likely to impact your service delivery and at what point your staffing levels become critical?
- Have you got arrangements in place to monitor and escalate risk?
- Are you having early discussion with your staff to help determine what measures you may need to take in terms of staff planning, for example if local schools close?
- Have you spoken to people you support about the plans you have?

We will gather the learning from these discussions and use this to inform and support the wider provider market.

The team will also be working to bring providers together to develop local support networks. These networks will be an opportunity to look at ways in which providers can develop local operational response plans together, offer mutual support and share good practice.

We will also be using part of the Council's annual Care Provider Conference on 17<sup>th</sup> March to support contingency planning .

#### Visitors to care homes or other building based care settings

Care homes do not need to close to visitors but it is good practice to stop open access to the home and you should discuss recent travel and risk factors with those entering as a precaution.

Please make sure you support normal service delivery with key partners such as social work, health services. There is no evidence that taking action early will be of any benefit to people.

- Do not stock pile PPE equipment

#### Coronavirus: New guidance for the adult social care sector

Vulnerable adults receiving social care will be better protected by <u>new guidance issued</u> to councils and care providers as the Government works to delay the spread of COVID-19.

The guidance covers a variety of scenarios relating to care homes, staff and providers who care for people in their own homes to ensure older people and those with pre-existing conditions who receive care are best protected.

The guidance calls for local authorities to work with the NHS and care providers to bring together their pre-existing contingency preparations and make sure each decision is made with the best public health and clinical advice at its heart.

# Read the guidance here >

Elderly people and those with underlying health conditions are much more likely to develop serious complications.

#### The guidance covers:

- Anyone who is suspected of having Covid-19, with a new continuous cough or high temperature, should not visit care homes or people receiving home care and should selfisolate at home.
- People receiving care will be isolated in their rooms if they have symptoms of coronavirus.
- Where close personal contact is required, care staff are to use protective equipment to minimise the risk of transmission.

The NHS will work with care providers where necessary to make sure people have the best possible care and remain in the community.

Dear colleague,

We are writing to share an update on how we are responding to the outbreak of Covid19, as well as how we plan to approach any future decisions as the situation develops.

We will always act in the best interests of people who use services – so while it's appropriate to recognise the need for you to focus on delivering care, we will always balance this with our responsibility to check that the safety of service users is maintained.

This is a fast-moving situation which may involve us changing what we do and how we do it. We have, therefore, established three key principles that we will use to make sure services continue to be safe, whilst limiting the impact on you and our own colleagues.

- We will be focusing our activity where it is needed most to ensure people receive safe care this means concentrating on those areas where we see that the risk to the quality of care is the highest and where we can make the biggest difference.
- We will support providers by looking at how we can act flexibly and proportionately to reduce the asks that we make of you including reducing what you need to do to prepare for inspection and looking at what we can do to limit our need to be on site.
- We will honour our duty of care to our colleagues at CQC.

We will still be carrying out inspections, but inspection managers will be reviewing inspection plans on an ongoing basis to make sure our activity is aligned with the very latest position. Most inspections will continue as planned in the short term, we will keep the position under review and may decide to postpone an inspection, perhaps with relatively short notice. We will take a pragmatic and flexible approach to how and when we regulate as and when this situation develops and we commit to continuing conversations with providers and their representative organisations.

We will continue to share updates with you through our regular communication channels, such as the provider bulletins, our <u>Twitter feed</u> and <u>our website</u>. The latest general official information coming from the Department of Health and Social Care, NHS England and Public Health England can be found here.

The government is currently coordinating the national response the outbreak of COVID-19 and has published its coronavirus action plan.

Public Health England (PHE) has published a range of <u>COVID-19 guidance for health professionals</u> – including guidance on the assessment and management of suspected UK cases, and specific guidance for <u>social or community care and residential settings</u>. The NHS has also updated its <u>coronavirus webpages</u>, bringing their guidance for social care staff and healthcare professionals into one place.



# Department of Health and Public Health England guidance regarding admission and care in a care home setting during COVID-19 incident

This document was initially circulated on Friday, but since then has had a link in Paragraph 5 updated, although the document is still called Version 1, dated 2<sup>nd</sup> April. The new version has an updated link:

The section that has the new link is Paragraph 5 below:

# 5. Advice for staff

The personal protective equipment (PPE) that must be worn when caring for possible or confirmed COVID-19 patients, is described in Annex F.

Care home staff who come into contact with a COVID-19 patient while not wearing PPE can remain at work. This is because in most instances this will be a short-lived exposure, unlike exposure in a household setting that is ongoing.

These are guiding principles and there should be an individual risk assessment based on staff circumstances, for example staff who are vulnerable should be carefully assessed when assigning duties, and where a possible or confirmed COVID-19 case is present in a care home, efforts should be made to cohort staff caring for that person. I would again like to thank you both for your participation in the event and also for the feed back that we have received since. We have received some very comments about the ability to be able to make claims for additional expenses incurred due to the current pandemic.

We also listened and heard that providers have already occurred some additional expenses due to the pandemic which has caused issues regarding their cash flow and that additional financial support is needed as a matter of priority. This has enabled us to secure approval to make a cash advance this week to our Residential and Nursing Care Homes, Homecare, Supported Living and Extra Care providers equivalent to 5% of their current commissioned packages for 2 weeks. This payment will be made to your organisation automatically this week but please be advised that they take 3 days to appear in your bank account.

In addition to this upfront payment, we are also proceeding with individual monthly Claim Forms as previously explained.

Just a reminder about appropriate use of PPE equipment - the excerpt below is taken from the guidance that has been issued locally. It is very important that PPE is used appropriately in order to best manage supplies across the health and care system in the county.

#### When to use PPE and conserving stocks

If neither the worker nor the individual receiving care and support is symptomatic, then no personal protective equipment is required above and beyond normal good hygiene practices.

Other general interventions should include increased cleaning activity and keeping property properly ventilated by opening windows whenever safe and appropriate.

It is essential that stocks of PPE are conserved and deployed sensibly. Local risk assessment and practical management should be pragmatic and proportionate, including consideration of whether there is actually a requirement to wear PPE at all.



# A reminder from Lead Infection Prevention and Control and Care Home Quality Lead Nurse about general IPC advice and Key information about Staff Uniforms:

General IPC advice hasn't changed regarding not travelling to and from work in your uniform.

For care staff in the community then changing into your uniform before starting your shift and getting changed straight after finishing your shift is still the advice.

General principles still apply and are <u>re-emphasised</u> that wearing a clean uniform for each shift is essential as the Covid-19 virus can attach itself to clothes so not wearing the uniform for anything other than work is essential.

Uniforms should be laundered:

- ✓ separately from other household linen;
- ✓ in a load not more than half the machine capacity;
- ✓ at the maximum temperature the fabric can tolerate, then ironed or tumbled-dried.

### **Furlough Leave**

"Furlough" is an American term, meaning to allow or force someone to be absent temporarily from work. The Government's Job Retention Scheme is a temporary scheme open to all UK employers for at least 3 months from 1<sup>st</sup> March 20. Employers can claim for 80% of furloughed employees' usual monthly wage costs, up to £2,500 a month. NB. This means you will be able to place employees who are shielding, in line with public health guidance, on furlough and claim back the above costs.

## For attention of care home managers:

Bassetlaw CCG are encouraging care homes to record the temperature of their residents on a **DAILY** basis. This could be useful practice for all care homes. Normal temperature as quoted in the NHS Digital National Early Warning Score (NEWS)2 is between 36.1 – 38.0 If one of your residents has a raised temperature we would encourage you to look at ways to reduce this eg removing clothing, opening a window, removing some of the bed covers and consider administering paracetamol. If the temperature has not responded to the measures you have taken after a period of time and you are concerned about your resident then consider contacting GP / Out of Hours for advice – it would be helpful to have an up to date temperature and details of the measures you have taken to reduce this prior to calling them.

Joint statement on advance care planning - British Medical Association (BMA), Care Provider Alliance (CPA), Care Quality Commission (CQC) and Royal College of General Practice (RCGP)

The importance of having a personalised care plan in place, especially for older people, people who are frail or have other serious conditions has never been more important than it is now during the Covid 19 Pandemic.

Where a person has capacity, as defined by the Mental Capacity Act, this advance care plan should always be discussed with them directly. Where a person lacks the capacity to engage with this process then it is reasonable to produce such a plan following best interest guidelines with the involvement of family members or other appropriate individuals.

Such advance care plans may result in the consideration and completion of a Do Not Attempt Resuscitation (DNAR) or ReSPECT form. It remains essential that these decisions are made on an individual basis. The General Practitioner continues to have a central role in the consideration, completion and signing of DNAR forms for people in community settings.

It is unacceptable for advance care plans, with or without DNAR form completion to be applied to groups of people of any description. These decisions must continue to be made on an individual basis according to need.

- the bodies of those people who have died as a result of coronavirus (COVID-19) and the bereaved family of the deceased are treated with sensitivity, dignity and respect
- people who work in these services and mourners are protected from infection

**PPE** 

As of yesterday, DHSC have issued a letter from their Chief Commercial Officer with an update on plans to support access to PPE across the health and care system. The letter sets out plans on how DHSC, NHSE/I, NHS Supply Chain and the Army have worked together to develop a Parallel Supply Chain (PSC) to support the normal supply chain which will be operational shortly. It also provides a FAQs section for those who are experiencing issues with the current system.

The National Supply Disruption Response (NSDR) helpline (24/7) is available for providers who have an urgent requirement for PPE, which they are unable to secure through their usual channels. Call 0800 915 9964. DHSC have updated the guidance provided to call handlers at the NDSR helpline in the light of negative feedback from councils and providers.

# Signposting people in the COVID19 high risk groups to self-management support and information

As a result of the Covid-19 pandemic, there is an important task across the Personalised Care Group to identify practical ways that we can support people staying at home. Supported self-management is of particular importance to people living with long-term conditions, who are at increased risk of severe illness from coronavirus (COVID-19).

- Identify and help respond to operational areas that are generating financial pressures for providers
- Provide financial support where necessary to those providers where there is a perceived risk of service failure
- Work jointly with the sector to ensure on-going provider sustainability
- Monitor take up of this support and provide an audit trail for the use of the funding

You will find guidance about what to do if care workers or individuals being cared for have symptoms of COVID-19. We would also like to reiterate that we do expect providers to follow this guidance wherever possible and not to immediately consider handing back packages of care where individuals are displaying symptoms.

The highest proportion of questions received today has been in relation to PPE equipment, I can advise you that we are hoping to hear later today that

there will be free distribution of fluid repellent facemasks. Delivery has started today (Wednesday 18<sup>th</sup> March), and every care home and home care provider will be receiving at least 300 facemasks. It is anticipated that the distribution will be complete by next Tuesday, this follows a recent change in the guidance. Providers are not required to take action; the stock will be delivered to them. I have heard from a provider already that they have received their masks today.

Work is also underway with wholesalers to ensure a longer-term supply of all aspects of personal protective equipment, including gloves, aprons, facemasks and hand sanitiser. For future PPE requirements, care providers should order PPE from their usual suppliers.

I also believe that a national hot line number is to be set up for providers. As soon as we receive further guidance we will of course forward to you.

I would also finally like to thank you all for your work to date in supporting people across the County and for also supporting your dedicated staff teams. We are indeed in very challenging times and our work together and strong relationship is going to help us get through this together.
