Adding Beeston Footpath No.133, commencing from a point, SK 5080 3748, at the junction with Moss Drive, Bramcote, and proceeding for a distance of approximately 254 metres in a south-westerly direction to a point, SK 5060 3734, at a gate on the boundary of Bluebell Wood (former Bramcote Hall Estate) and having a width of 4.7 metres throughout the whole of its length.

If the Order is submitted to the Secretary of State for the Environment, (in whole or in part), any representations or objections which have been duly made and not withdrawn will be sent with it.
