STATEMENT MODIFICATION ORDER 2020

This Order is made by the Nottinghamshire County Council ("the Authority") under Section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the Authority that in the interests of the owner of the land crossed by the (footpath) and the public it is expedient that the line of the path should be diverted.

This Order is also made under Section 53A(2) of the Wildlife and Countryside Act 1981 ("the 1981 Act") because it appears to the Authority that the Rushcliffe area Definitive Map and Statement require modification in consequence of the occurrence of an event specified in Section 53 (3) (a) (i) of the 1981 Act, namely, the diversion (as authorised by this Order) of a highway shown or required to be shown in the Map and Statement.

The Rushcliffe Borough Council has been consulted as required by Section 120(2) of the 1980 Act and by Schedule 15(1) of the 1981 Act.

BY THIS ORDER:

1. The public footpath over the land situate at Kinoulton and shown by a bold continuous line on the map contained in this Order and described in Part 1 of the Schedule to this Order shall be stopped up after confirmation and certification of this Order, and thereupon the Rushcliffe Area Definitive Map shall be modified by deleting from it that public right of way.
2. There shall be upon confirmation and certification of this Order a footpath over the land situate at Kinoulton described in Part 2 of the Schedule and shown by a bold broken line on the map contained in this Order, and thereupon the Rushcliffe area Definitive Map shall be modified by adding that path to it.
3. The Rushcliffe Definitive Statement shall be modified as described in Part 3 of the Schedule to this Order.

PART 1

Description of Site of Existing Path or Way

Commencing from a point, SK 6970 3040, at the junction with the remainder of Kinoulton Footpath No.21, and proceeding in an east-north-easterly, then generally south-easterly direction, to a point SK 7024 2997, at the junction with the northern side of Clarke's Bridge over the Grantham Canal, for a total distance of approximately 940 metres.

PART 2

Description of Site of New Path or Way

Commencing from a point, SK 6970 3040, at the junction with the remainder of Kinoulton Footpath No.21, and proceeding in a generally south-south-easterly direction along the western side of the hedge line, to a point, SK 6988 2999, at the junction with the tarmac track, then proceeding across the tarmac track on to the eastern side of the hedgerow in a south-south-easterly direction, to a point, SK 6996 2986, and proceeding in a generally north-easterly direction across a field, to a point SK 7023 2996, then proceeding in south-easterly direction to a point, SK 7024 2997 the remainder of Kinoulton Footpath No. 21, for a total distance of approximately 920 metres.
