

**THE HEALTH PROTECTION (CORONAVIRUS, RESTRICTIONS) (ENGLAND)  
(NO. 3) REGULATIONS 2020 (No.2020/750)<sup>1</sup>, REGULATION 4(1)**

**NOTICE OF  
REVOCATION OF DIRECTION NO1**

- 1. Nottinghamshire County Council** (“the Authority”), in exercise of the powers conferred by regulation 4(1) of the Health Protection (Coronavirus, Restrictions) (England) (No. 3) Regulations 2020<sup>2</sup> (“the No. 3 Regulations”), made a direction “Direction No1” dated the 9<sup>th</sup> October 2020 in respect of the Addressee(s) and Premises identified below that the Premises would remain closed between the period 6.00pm (1800 hrs) 9<sup>th</sup> October and 6.00pm (1800 hrs) 6<sup>th</sup> November 2020 subject to 7 day review.
  
- 2 Upon** a 3<sup>rd</sup> review dated the 29<sup>th</sup> October 2020 of Direction No1 the Authority is satisfied that the Addressees having taken into account all available evidence including representations from the Director of Public Health that the grounds justifying the imposition of Direction No1 are no longer met and that Direction No1 is revoked from 6.00pm (1800 hrs) 29<sup>th</sup> October 2020 pursuant to a determination under section 2 (3) (a) of the No 3 Regulations.
