May I please have a copy of any records that would show some or all of the following information:

1. A list of ALL hedge funds and fund of hedge funds in which Nottinghamshire County Council Pension Plan is an investor; and

2. For each hedge fund and fund of hedge funds, may I please have a copy of any records that would show some or all of the following information:

a. the month by month market value of Nottinghamshire County Council Pension Plan's holding in each fund since the Nottinghamshire County Council Pension Plan initial investment in hedge funds to 30 September 2020,

b. the month by month amount invested by Nottinghamshire County Council Pension Plan in each fund since the Nottinghamshire County Council Pension Plan initial investment in hedge funds to 30 September 2020,

c. the month by month net returns (net of fees) earned by Nottinghamshire County Council Pension Plan on its investment in each fund since the Nottinghamshire County Council Pension Plan initial investment in hedge funds to 30 September 2020.
