

**NCC-047054-20 Highway spends district and boroughs 2016-2018**

Dear Requester,

Further to your request for information under the freedom of information act, please see below.

The information requested for the highway spend data is not monitored at a district level. The data we hold is managed at a countywide level and the following data is information that we had previously collated for spend by calendar year.

Whilst not based on financial year, it does give you an indication of the associated spend pending your response to the following.

We have interpreted 'highway repair' to mean reactive maintenance for both carriageway and footways i.e. day to day pothole and patching repairs, figures as above. If you require the data to cover planned and preventative maintenance, which are also repair methods for larger scale highway maintenance activities, through machined treatments i.e. resurfacing, surface dressing, etc, this information can be provided.

Also, we are unsure whether you wish to have drainage maintenance including which is another area of repair spend. Therefore, the above is for information pending a more detailed response on the areas of maintenance you require the figures to cover.

We trust at this time the information now resolves your enquiry and where we have not been able to provide details we expect that this information is not held by Nottinghamshire county Council at this time.

We suggest all requesters search under our publication scheme in advance of requesting information under the freedom of information act.
