Thank you for your Freedom of Information Request.

The Councils Response is as follows:

- 1. The Council's Legal Service, which sits in the Chief Executive's Department, is responsible for most legal service provision within the Council. They provide advice and support to all of the Council's Departments and services and may seek specialist external advice from external legal firms or barristers as appropriate. The Council's Trading Standards Service, which sits in the Place Department also has some direct responsibility for legal matters relating to their service area but will also seek advice from the Legal Service where appropriate, including advocacy support from barristers. Legal advice is provided to the relevant Departments who are responsible for the overall service delivery of services within their areas.
 - (i) Heather Dickinson, Group Manager for Legal, Democratic and Complaints is the head of the Legal Practice at the Council and is responsible for the Legal Service. She reports to Marjorie Toward who is the Council's Monitoring Officer and the Service Director for Customers, Governance and Employees. Heather's contact details are: heather.dickinson@nottscc.gov.uk whilst the monitoring officer can be contacted through monitoring.officer@nottscc.gov.uk . Mark Walker is the Group Manager for Trading Standards and Communities and can be contacted through mark.walker@nottscc.gov.uk
 - (ii) All litigation work (except relating to some trading standards legal work) is managed on a day to day basis by Geoffrey Russell, Team Manager for Litigation which covers each of your areas listed in (ii) except Intellectual Property, which falls within the Corporate and

Environmental Law team which is managed on a day to day basis by Sorriya Richeux who is the Team Manager.

Any Department which runs services may have staff who are required to give evidence at a legal hearing and they would be primarily responsible for their support and training but services may seek assistance from colleagues in Legal Services, as appropriate.
