



**THE NOTTINGHAMSHIRE COUNTY COUNCIL (EDINGLEY PUBLIC FOOTPATH 11 and
FARNSFIELD PUBLIC FOOTPATH 20)
(TEMPORARY PROHIBITIONS) NOTICE 2021**

NOTICE IS HEREBY GIVEN that the Nottinghamshire County Council (in exercise of its powers under Section 14(2)(b) of the Road Traffic Regulation Act 1984) being the traffic authority for the length or lengths of highway referred to in this Notice, hereby directs, because the restriction or prohibition should come into force without delay, that:-

- (1) **No person shall proceed on foot** in the following footpath at Edingley and Farnsfield in the District of Newark and Sherwood;-

Edingley Footpath No. 11 (at Greaves Lane grid. Ref. SK 651 548) becoming Farnsfield Footpath No. 20 at the parish boundary) to the junction with Farnsfield Footpath No. 28 (grid. Ref. SK 651 552) becoming Edingley Footpath No. 12 at the parish boundary

- (2) **The alternative route for pedestrians is Greaves Lane and Edingley Footpath No.12/Farnsfield Footpath No.28**

- (3) The Temporary Notice is required from **18th January 2021** to protect public safety over an out of repair footbridge and a boggy/waterlogged/deep silted path and to allow repairs to be made.

Further Notice

- (a) No prohibition, restriction or prescription contained in this Notice shall apply to any person acting in accordance with any permission or direction given by a Police Constable in uniform.
- (b) Nothing in paragraph (1) of this Notice shall apply so as to make it unlawful for any vehicle to proceed in the length of highway specified in the said paragraph for the purposes of access to or egress from premises, provided that the said access or egress may only be gained by proceeding over the length of highway specified in the said paragraph, provided that the works being carried out would not be inconveniently interrupted.
- (c) Nothing in paragraph 1 of this Notice shall apply to any person proceeding in connection with works to be carried out in or in the vicinity of the length or lengths of highway specified in the said paragraph.
- (d) Nothing in Paragraph 1 of this Notice shall apply to any person proceeding in connection with the works in the length or lengths of highway specified in this Notice.
- (e) This Notice is valid for a period of 21 days from the date of this Notice. This Notice may be continued by a further 21-day Notice and/or a Continuation Order (within a maximum period of 6 months).
