#### Item 1. Welcome and apologies for absence

Councillor Kay Cutts welcomed members to the seventh meeting of the Nottinghamshire County COVID-19 Outbreak Control Engagement Board. This meeting was extended to include all District and Borough Leaders and Chief Executives and superseded the board due to take place on 14 December 2020.

Apologies were received from Idris Griffiths (Chief Officer, Bassetlaw CCG), Ruth Hyde (Chief Executive of Broxtowe Borough Council) and Kath Marriott (Chief Executive of Rushcliffe Borough Council) and deputies were provided.

#### Item 2. COVID-19 in Nottinghamshire: situation overview

Jonathan Gribbin provided a summary of the latest situation in Nottinghamshire. During the discussion the following points and actions were raised:

No.	Point / action	Action owner	By when
1.	Across Nottinghamshire, rates of COVID-19 have reduced in all districts. In the most recent complete 7-days, the rates in the 60s and over age group has plateaued. The all age case rates across the districts range from 255 per 100,000 in Bassetlaw to 105 per 100,000 in Rushcliffe. The higher rate in Bassetlaw is in part linked to two known outbreaks, which are being supported by the Local Authority Public Health Team.		
2.	Inpatient bed numbers for COVID-19 fell below 400 in the last week, but this decrease has since plateaued. National data indicates that hospital admission rates appear to be rising across the Country and modelling indicates Nottinghamshire may see an increase in admissions over the next two weeks.		
3.	In response to a query from Simon Greaves, Jonathan Gribbin provided an update on asymptomatic testing and use of lateral flow tests (LFTs). Nottinghamshire County Council are working with the regional coordinating team and neighbouring authorities to explore how LFTs can be used and targeted effectively. Sarah Carter also confirmed that Nottingham and Nottinghamshire are well served with regards to symptomatic testing, with 7 local testing sites in the City and 6 Countywide local testing sites in place, as well as two Mobile Testing Units that are rotated throughout the County as required.

	4.	In response to a query from Councillor Steve Carr regarding

## Item 3. Review of tier arrangements

Helen Marks provided an overview of the review process for tier arrangements. During the discussion the following points and actions were raised:

No.	Point / action	Action owner	By when
5.	National review of the existing tier arrangements is due to take place on 16 December 2020. Upper tier authority areas will be the building blocks for the review, taking in to account population mobility. Leaders and MPs will be briefed by Ministers on the review process.		
6.	Factors that will be taken in to account as part of the review process include case rates (both for all ages and over 60s), rates of change (the rate that cases are rising or falling), pressures on the National Health Service (NHS) and positivity rates. Epidemiological data up to 10 December will be considered in the review on 16 December 2020.		

## Item 4. COVID-19 vaccine rollout

Sarah Carter provided an update on the COVID-19 vaccine rollout in Nottinghamshire (including an overview of the system delivery model and the workforce plan). During the discussion the following points and actions were raised:

No.	Point / action	Action owner	By when
7.	The Pfizer-BioNTech vaccine has now been approved by the Medicines and Healthcare Products Regulatory Agency (MHRA) and Nottinghamshire is in the delivery phase of the vaccination programme. The first vaccinations have now been delivered in the hospital hubs (Kings Mill Hospital and Queens Medical Centre). Vaccines are currently being administered to priority individuals, including care home staff, the over 80s age group and the NHS workforce.		
8.	Two large vaccination centres are anticipated to be operational in the coming weeks, along with further community vaccination sites. The intention is also to move towards a roving system of vaccination delivery in care homes and to support those that are home bound.		

9.	The Oxford-AstraZeneca vaccine has been submitted to the regulator for approval and 100 million doses have been preordered for the Country. Delivery of the Oxford-AstraZeneca vaccine will be less complex than the Pfizer-BioNTech vaccine, due to the fact that it does not need to be stored at very low temperatures.	
10.	Recruitment to support the Vaccination programme in Nottinghamshire continues and those interested in joining the COVID-19 vaccine bank are encouraged to apply. The importance of individuals waiting to be contacted by the NHS for their vaccination appointment was also emphasised.
