Potholes are only one type of highway surface failure and hence the budget is not assigned to just potholes but the management of the Highway Network to maintain it in a safe condition for use. This is known as Reactive Maintenance and is an outcome of enquiries/reports to the County Council along with actionable defects identified through the planned inspection regime. The annual budget for this type of work, excluding Planned Structural Patching and Planned Resurfacing work is in the region of £3.5 to £5.5m

depending on the type of Winter we experience and the level of deterioration on the Highway Network. Budgets are set at the lower level at the beginning of the financial year but as we have a duty to keep the Highway Network safe for users, the necessary repairs are undertaken, and the associated funding provided through adjustments to other Highway Maintenance activities.

Please note, the calculation we have done for 2020 is more accurate than previous figures supplied as we have liaised more closely with Finance to better capture the impact of the capital/revenue split. We will be able to apply these calculations to the 2018 and 2019 figures retrospectively but not for today, we will be applying this formulae going forward.
