Thank you for your request for information relating to EIR request relating to all records of communication relating to building works to the Orchard, Sutton-in-Ashfield, Nottinghamshire. Specifically;

- A. All information relating to the adoption of the Orchard including Maps, Measurements emails etc.
- B. All communications relating to the gate and permissions associated with it. This would be from 1.1.14 to current dealings
- C. Communications relating to boundary and planning issues in relation to 6 The Orchard
- D. Any communications relating to planning advice or applications with reference to 14 Vellus Court Sutton In Ashfield from 2014 to current time.

Please find attached an extent plan showing (shaded in green) what the County Council believes to be the limit of highway maintainable at public expense for the above road. We have also included the asset summary which shows the length of the road.
