Dear Requester,

Further to your request for information under The Freedom of Information Act.

The response for this FOI is set out below:

Further to your recent enquiry requesting information regarding inspections outside 60 Loughborough Road, NG2. Please find attached a Street History report for this street section which details Condition Surveys (Inspections), Enquiries received, Maintenance management (works) and Street Works noticing for the time period 01/01/2018 to 22/04/2021. This report is run from Nottinghamshire's Highway Asset Management System (HAMS) and is an extract of data held on for Loughborough Road, West Bridgford (33001159-2001) specific to street section 2001 as detailed in the map below ([blue](#)).



The inspection frequency for this street section is set out below for the carriageway and footways.

Carriageway Inspection Frequency	Monthly
Footway Inspection Frequency	Quarterly (four times a year)

The County Council's Highway Inspection & Risk Manual (HIRM) provides the policy for inspections and can be found at:

Cross referring to the HIRM will explain notation in the street history report. The method of inspection is set out in the HIRM but as this enquiry relates to the footway it will be a walked inspection.

We require street inspection records to include, driven surveys, walk- about surveys and any other general maintenance records. For the sake of completeness, we should appreciate confirmation as to whether a s81 notice was issued in relation to the subject defect. We have searched our database and have been unable to locate a s81 notice. Please confirm if such notice exists and if so, please provide a copy.

Please also advise:

- how often inspections are undertaken
- the method of inspection
- provide a copy of your inspection policy.
