hereby apply for an Order under Section 53(2) of the Wildlife and Countryside Act 1981 modifying the Definitive Map and Statement for the area by:

- 1. adding the bridleway from Kneesall Road, Laxton at point A to Laxton & Moorhouse FP15 at point B and from FP15 at point C to the western end of Copthorne Lane and along the lane to Ossington Road, Moorhouse at point D on the map.
- 2. **upgrading** to a bridleway, the footpath Laxton & Moorhouse FP15 between points B & C on the map


