I appreciate that despite being short term projects (delivery by 2024) some of these schemes may be in the early design stages. If that is the case and there is a sensitive reason why these designs cannot be released, I would appreciate the proposed principles and objectives of these schemes, confirming they will be designed in accordance with LTN 1/20.

There are currently no designs available for consultation on the schemes listed above. The public and stakeholders will, however, have the opportunity to comment on any future cycling infrastructure proposals through the appropriate consultation on such programmes and individual schemes. These programmes are approved annually as part of the Council's highways programmes reports and the 2021/22 highways programmes will be determined by County Council members following the elections on 6 May 2021.

The County Council's Communities & Place Committee recently reviewed and determined its overarching <u>priorities for the future provision of cycling infrastructure</u> in order to help deliver the wider national, regional and local objectives. At the same meeting, Committee also approved the incorporation of 'Local Transport Note 1/20: Cycle Infrastructure Design' standards into the County Council's existing highway design principles.

The County Council, working in partnership with Derby city, Derbyshire, and Nottingham city councils is developing the D2N2 Local Cycling & Walking Infrastructure Plan (LCWIP) to help identify and prioritise a strategic cycling network across the D2N2 area. The work undertaken to date on the D2N2 LCWIP has helped identify potential routes that may be prioritised for future investment but not feasibility of providing infrastructure along these routes or actual scheme designs. The County Council is currently undertaking additional technical analysis to supplement the D2N2 LCWIP to help identify, evaluate and prioritise potential cycle route improvements across the whole of Nottinghamshire in a consistent way. Once this work is complete, County Councillors will consider the findings and determine the routes that will be priorities for future investment, including those that will be taken forward for further feasibility and design.
