MAP AND STATEMENT MODIFICATION ORDER 2021

This Order is made by the Nottinghamshire County Council ("the Authority") under Section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the Authority that in the interests of a landowner of the land crossed by the footpath it is expedient that the line of the path should be diverted.

This Order is also made under Section 53A(2) of the Wildlife and Countryside Act 1981 ("the 1981 Act") because it appears to the Authority that the Rushcliffe Area Definitive Map and Statement require modification in consequence of the occurrence of an event specified in Section 53 (3) (a) (i) of the 1981 Act, namely, the diversion (as authorised by this Order) of a highway shown or required to be shown in the Map and Statement.

The Rushcliffe Borough Council has been consulted as required by Section 120(2) of the 1980 Act.

BY THIS ORDER:

1. The public right of way over the land situate at Sutton Bonington and shown by a bold continuous line on the map contained in this Order and described in Part 1 of the Schedule to this Order shall be stopped up upon certification of this Order, and thereupon the Rushcliffe Definitive Map shall be modified by deleting from it that public right of way.
2. There shall at the end of 7 days from the date of confirmation of this Order be a footpath over the land situate at Sutton Bonington as described in Part 2 of the Schedule to this Order and shown by a bold broken line on the map contained in this Order, and thereupon the Rushcliffe Area Definitive Map shall be modified by adding that path to it.
3. The Rushcliffe Area Definitive Statement shall be modified as described in Part 3 of the Schedule to this Order.

SCHEDULE

PART 1

Description of Site of Existing Path or Way

Commencing from a point, SK 5044 2488, at the junction with Sutton Bonington Bridleway No.5 and proceeding for a distance of approximately 408 metres in a generally south-westerly then north-westerly direction to a point SK 5008 2469, at the junction with the remainder of Sutton Bonington Footpath No.6.

PART 2

Description of Site of New Path or Way

Commencing from a point, SK 5044 2488, at the junction with Sutton Bonington Bridleway No.5 and proceeding in a generally south-westerly direction between fences for a distance of approximately 400 metres before passing over a stone bridge at a point, SK 5012 2462, then continuing in a north-north-westerly direction for a further 60 metres, to a point, SK 5008 2469, the junction with the remainder of Sutton Bonington Footpath No.6. and having a grass surface and a width of 2 metres throughout its diverted length of approximately 460 metres.
