At this meeting, Cllr Dr John Doddy was appointed as Chair of the Health and Wellbeing Board, Dr Jeremy Griffiths as Vice-Chair and the membership of the Board for the municipal year 2021 – 2022 was noted.

CHAIR'S REPORT

The report highlighted a number of items for the Board's information, including the plans for delivering the Domestic Abuse Duty and funding for substance misuse interventions in Nottinghamshire. The Chair noted that these were important services, especially in consideration of the impacts the pandemic will have had on vulnerable individuals. Social isolation and restrictions will have exacerbated issues and increased the need for support. Board members shared additional concerns regarding the impacts the pandemic on new parents and new-borns/infants, county lines and related safeguarding concerns, children and young people's mental health and suicide prevention. The Vice-chair commented that in regard to the Government's loneliness strategy and the isolation individuals will have been subject to because of the pandemic, the Board should consider investigating the issue of loneliness in Nottinghamshire.

LOCAL AREA COORDINATION IN NOTTINGHAMSHIRE

Clare Gilbert, Group Manager (strategic commissioning), provided a presentation regarding Nottinghamshire County Council's approach to Local Area Coordination. This is an all age support model and community based approach which supports individuals to stay as independent as possible within their own communities and to ensure that all interventions seek to maximise their independence. Adult Social Care & Health is implementing the Local Area Co-ordination approach in Nottinghamshire, for an initial period of 18 months and forms part of the Local Authority's Prevention Strategy. <u>Community Catalysts</u> have been procured to support with its integration for the next 18 months (starting in May 2021). The Board approved the recommendation to receive a workshop on Local Area Coordination on Wednesday 28th July 2021, in order to engage support from our local partners and communities.

POPULATION HEALTH MANAGEMENT & LRF DATA AND INFORMATION CELL

Amanda Robinson, Programme Manager (PHM), provided a presentation updating on the Nottingham and Nottinghamshire Integrated Care System's approach to Population Health Management and how it has been utilised in the past year to support the response to Covid-19, via the Information and Data Cell. The Cell has been closely involved in the emergency response to covid-19 and provided local and national data to monitor covid-19 and inform briefings, planning and decision-making. The Cell and PHM approach was also used to undertake a Mental Wellness Review, Flu Vaccination Program and Winter Planning, and delivery of the COVID-19 Vaccination Program. On the last note, Amanda reported that as of Tuesday 8th June 1 million vaccinations had been administered in Nottinghamshire, with Board members noting the importance and hard work in reaching this milestone and gave thanks to all those involved in the vaccination programme.

APPROVAL OF THE 2020/21 BETTER CARE FUND YEAR END REPORTING TEMPLATE

A report was submitted to the Health and Wellbeing Board to approve the 2020-2021 Better Care Fund End Year Reporting Template, that was submitted to NHS England on 24 May 2021. The Better Care Fund (BCF) programme supports local systems to deliver the integration of health and social care. Successes during 2020 – 2021 were also highlighted within the report, including the enhancement of system governance and leadership, and joint approach to supporting and managing quality and workforce issues in an integrated way for the home care and care home sectors. Next steps include a review into programme areas and partnership governance arrangements for greater integration, considering the positive progress made to establish system response during the pandemic and the direction of travel outlined in the NHS White Paper: 'Integration and Innovation: working together to improve health and social care for all', published in February 2021.

UPDATE ON THE PHARMACEUTICAL NEEDS ASSESSMENT (PNA) 2022 - 2025

Mina Fatemi, Public Health and Commissioning Manager (NCC), presented the report on the plans to refresh the PNA for 2022 – 2025. The PNA describes available pharmaceutical services across Nottinghamshire County and provides an assessment of need. It provides NHS England with robust and relevant information to support decisions around new and altered pharmaceutical services. The Health & Wellbeing Board is included in the consultation for these pharmacy applications. Following guidance issued from the Department of Health, the refresh of the PNA that was scheduled for April 2021 has been moved to October 2022. In March 2021 Nottinghamshire County Council and Nottinghamshire City Council have jointly signed agreements with Primary Care Commissioning Community Interest Company (PCC CIC) to undertake the PNA refreshment for October 2022.

The Board subsequently approved this revised approach and agreed to receive a more detailed paper on the plans to refresh the PNA later in 2021.
