This Order is made by the Nottinghamshire County Council ("the Authority") under Section 26 of the Highways Act 1980 ("The 1980 Act") because it appears to the Authority that, having regard to the matters set out in Section 26(1), there is a need for a bridleway over the land to which this Order relates, and that it is expedient that the path should be created.

The Mansfield District Council has been consulted as required by Section 26(3) of the 1980 Act.

BY THIS ORDER

1. There shall be at the end of 7 days from the date of confirmation of this Order a bridleway over the land at Warsop described in the Schedule to this Order and shown by a bold hatched line on the Map attached to this Order, and thereupon the Mansfield Definitive Map and Statement shall be modified accordingly.

Description of Land

Commencing from a point, SK 5649 6485, at the junction with Peafield Lane and proceeding for a distance of approximately 700 metres in a south-easterly, south-south-westerly, south-south-easterly, south-easterly then south-south-easterly direction to a point, SK 5678 6429, at the junction with Warsop Bridleway No.18 and having a width of 3 metres throughout the whole of its length.

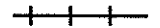

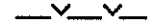
