Further to your request for information under The Freedom of Information Act, please see below.

FOI - Enquiry Details

I would like to be provided with the total section 106 funding provided by Woodhead Homes and Harworth Developments for supporting of local infrastructure in Edwinstowe.

I would also like to understand how much of the funding has been spent and where. Specifically I would like to understand the cash allocated to support new school places being generated in the village.

I would also like to understand any section 106 monies that have been refunded to developers as unspent over 2 years.

Harworth Estates, Thoresby Colliery, 800 dwellings (application ref. 16/02173/OUT)

Education	Provision of a new primary school	n/a	The developer is required to construct a 210-place primary school on the primary school land allocated within the development site. The construction is to be completed on the first anniversary of the date of occupation of the 151st dwelling.
Highways	£1,198,000.00	£1,313,214.92	To be used to improve, upgrade and maintain the Ollerton Roundabout at the A614/A616/A6075 junction.
Libraries	£35,130.00	£0.00	To be used towards additional stock at Edwinstowe Library.

N.B. the infrastructure referred to above relates only to County Council delivered services; further information relating to District Council infrastructure is not provided.
