- And, if time permitting, the percentage of the energy that comes from renewable sources **We don't buy green tariff energy, so the proportion of power that is green is reflected in the fuel mix reported by our current electricity supplier, EDF - [Our Fuel Mix | EDF \(edfenergy.com\)](#) Solar panels (PV) on our properties generate about 1million kWh p.a., much of which is consumed by the sites themselves. We also have a number of sites heated by wood pellets, most of which are schools. Electricity and gas are procured through a Crown Commercial Service supply framework.**
