

## Voluntary Sector Grants and Funding Privacy Notice

### Introduction

This privacy notice explains how the Council uses your data to process applications for voluntary sector funding, and to monitor funded projects and activities.

### Who will be using your data?

Nottinghamshire County Council will be the data controller for the data you provide to us.

We may also contract third party organisations to process your data on our behalf.

### What personal data do we use?

- Name
- Contact details, eg. phone, email
- Age
- Address
- Parent/carer details (if relevant)
- Photos and videos (if relevant)

### What types of special category personal data do we need from you?

- Health data (if relevant)
- Racial or ethnic origin (if relevant)

### Why do we use your data?

- For service delivery, eg. to assess applications and administer grant funding
- For service planning, training and improvement

### What legal reasons allow us to use your data in this way?

Our legal basis for processing your personal data is it is necessary to perform our public tasks as a local authority.

Publicity photos and videos are processed on the basis of consent.

### Who may we share your data with or receive it from?

- Voluntary and charitable organisations

### May personal data be transferred overseas?

The Council may for operational purposes transfer personal data overseas. In these cases, we will ensure that your personal data is protected and there are safeguards

for the protection of your rights. Please refer to the [County Council's privacy statement](#) for further details.

### **How long is your data kept for?**

This information is held in accordance with the Council's retention schedule – see [here](#).

### **What will happen if you do not provide or we cannot obtain the data needed?**

- We could not process your application, provide funding or support for your project or activity.

### **Does the service make decisions using fully automated processes?**

No.

### **What rights do you have over this use of your data?**

- To be informed about how we use your data
- To access a copy of your data that we process
- To have us rectify or correct your data that we process
- To restrict our processing of your personal data
- To object to the use of your data
- To have your personal data erased
- To request that we transfer your information to you or another organisation
- To object to fully automated decision making
- To withdraw your consent (if it the legal reason why we use your data).
