This Order is made by the Nottinghamshire County Council under Section 53 (2) (b) of the Wildlife & Countryside Act 1981 ("the Act") because it appears to that Authority that the Nottinghamshire Definitive Map and Statement modification in consequence of the occurrence of an event specified in Section 53 (3) (c) (i) of the Act, namely the discovery of evidence that a right of way subsists or is reasonably alleged to subsist over land situated in Marnham.

The Authority have consulted with every Local Authority whose area includes land to which the Order relates.

The Nottinghamshire County Council hereby order that:

1. For the purposes of this Order the relevant date is 19th August 2025.
2. The Nottinghamshire Definitive Map and Statement shall be modified as described in Part I and Part II of the Schedule and shown on the Map attached to this Order.
3. This Order shall take effect on the date it is confirmed and may be cited as "The Nottinghamshire County Council Marnham Footpath No.10 Modification Order 2025".

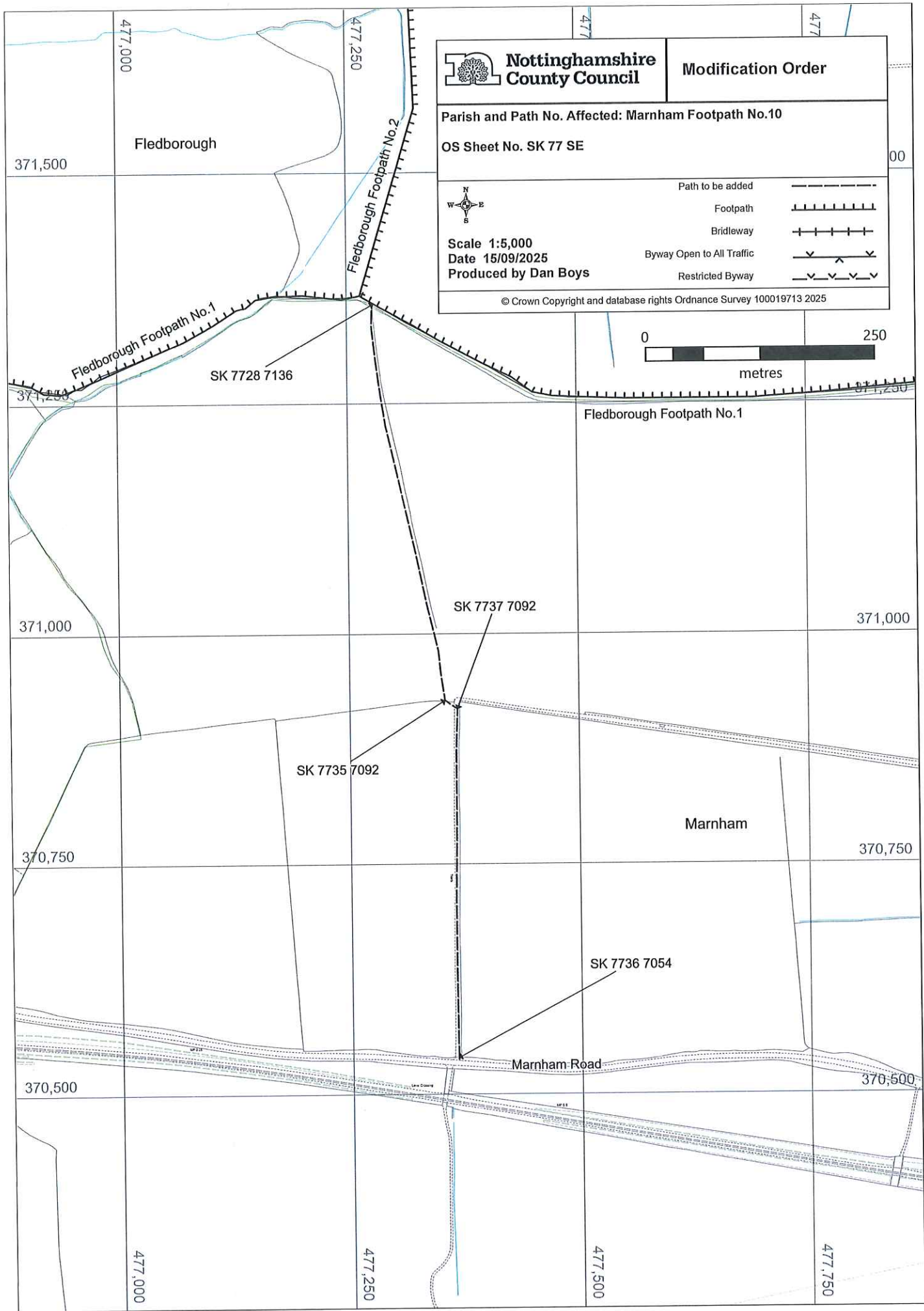

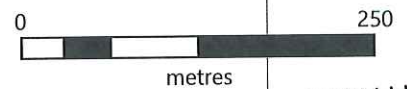
