The Public Sector Equality Duty which is set out in the Equality Act 2010 requires public authorities to have due regard to the need to: Eliminate unlawful discrimination, harassment and victimisation; Advance equality of opportunity between people who share a protected characteristic and those who do not; Foster good relations between people who share a protected characteristic and those who do not.

The purpose of carrying out an Equality Impact Assessment is to assess the impact of a change to services or policy on people with protected characteristics and to demonstrate that the Council has considered the aims of the Equality Duty.

## Part A: Impact, consultation and proposed mitigation

1 What are the potential impacts of proposal? Has any initial consultation informed the identification of impacts?

The Council plan is due to be considered by Full Council in the autumn of 2021 and will contain the Council's priorities and ambitions both in the short and long-term, with a particular focus on recovering from the Covid-19 pandemic. In order to ensure that community needs and concerns are reflected, a public engagement exercise will be undertaken to capture views of residents from across the county.

As such, to best assess resident priorities and aspirations, engagement will take the form of an open access survey (online and paper copies in venues), as well as a representative sample via an external engagement company DJS, focus groups and targeted engagement through service departments. The engagement will ask high level questions to gauge how communities have been affected by the pandemic, alongside their priorities for the future.

To ensure residents can access the survey in a format accessible to them, particularly with regard to age, race and disability, some alternative versions shall be made available. This includes paper copies in libraries for those who don't have internet access, an option to call the customer service centre to go through the survey on the phone, a video relay service with the Customer Service Centre for British Sign Language users, an easy read version, as well as alternative formats/languages being made available on request. A specific version for young people is also being created.

The aim of this engagement is to;

 understand the impact of the pandemic and associated societal restrictions on our communities

- understand what residents and stakeholders consider to be the challenges and opportunities as we recover from the pandemic
- understand what residents long term aspirations are for themselves, their communities and the county.

DJS Research, a market research company who is available to NCC via a procurement framework agreement, will be commissioned to undertake representative sampling/ market research via telephone and in person (on the streets). The third party will be responsible for sourcing participants.

Data collected will be used to inform the priorities in the new Council Plan. The questions asked during the engagement will capture a broad range of views and opinions as to how the Council should move forward in the best interests of Nottinghamshire communities. This will include the use of location and equalities data to map views and priorities across the county.
