The Government published the Resources and Waste Strategy for England in December 2018 which sets out a roadmap towards increasing recycling rates across England. There have since been 2 consultations on the proposals included within that Strategy and the Environment Bill (intended to bring these plans into law) has started its route through Parliament.

Any improvements or changes to the current recycling service in Nottinghamshire will be made in line with the Resources and Waste Strategy to ensure consistency with the new national strategy and any relevant legislation.

What schemes do you encourage or endorse to lower our carbon footprint, reduce landfill, and develop sustainability?

The County Council currently send's less than 5% of waste to landfill for disposal. The proposals within the Resources & Waste Strategy should also help this. Included within the Resources and Waste Strategy are proposals to mandate weekly food waste collections, free garden waste collections and other recycling initiatives.

The County Council supports and promotes initiatives that adhere with the waste hierarchy (National recycle week, textile reuse, Love Food Hate Waste - food waste reduction, home composting) through communications and providing residents with educational material and information.
