## **High Needs Provision Capital Allocation**

In 2021, the Department for Education announced that it would provide local authorities with a High Needs Provision Capital Allocation (HNPCA) for the 2021-22 financial year. The HNPCA is to be paid to local authorities in a single instalment in July 2021.

As part of the assurance arrangements for this grant, the Department for Education requested that each local authority provide:

"a short grant assurance data return to provide details of projects they intend to fund using their HNPCA return. Local authorities therefore should complete the published template on GOV.UK, setting out their intentions for the funding. Completed templates should be returned to the department by 30 June 2021 by emailing the completed template to:
