## THE NOTTINGHAMSHIRE COUNTY COUNCIL (LOWDHAM FOOTPATH NO.3, NO.4, NO.5 AND UNREGISTERED BECKSIDE PATH) (TEMPORARY PROHIBITION) NOTICE 2021

**NOTICE IS HEREBY GIVEN** that the Nottinghamshire County Council (in exercise of its powers under Section 14(2)(b) of the Road Traffic Regulation Act 1984) being the traffic authority for the length or lengths of highway referred to in this Notice, hereby directs, because the restriction or prohibition should come into force without delay, that:-

(1) No person shall proceed on foot in the following lengths of footpath at Lowdham in the District of Newark and Sherwood; -

**Lowdham Footpath No.3**, its entire length between the A612/ Main Street Junction and the A6097.

**Lowdham Footpath No.4**, its entire length between the A6097 and the footbridge over the Lowdham Beck.

Lowdham Footpath No.5, over the footbridge at the Lowdham Beck.

<u>Unregistered Beck side Path</u>, from its junction with the A612/Main Street to the footbridge over the Lowdham Beck.

- (2) The only alternative route for pedestrians is along the roadside footway.
- (3) The Temporary Notice is required from **18<sup>th</sup> October 2021** to protect public safety while works on the flood defences take place.

This Notice supersedes the Temporary Traffic Regulation Order <u>"THE NOTTINGHAMSHIRE</u> <u>COUNTY COUNCIL (LOWDHAM FOOTPATH NO.3, NO.4 AND UNREGISTERED BECKSIDE</u> <u>PATH ) (TEMPORARY PROHIBITION) ORDER 2021</u>" as it was necessary to include the footbridge in the restrictions, and further exclude the public, to safely carry out flood defence works on site.

## Further Notice

- (a) No prohibition, restriction or prescription contained in this Notice shall apply to any person acting in accordance with any permission or direction given by a Police Constable in uniform.
- (b) Nothing in paragraph (1) of this Notice shall apply so as to make it unlawful for any vehicle to proceed in the length of highway specified in the said paragraph for the purposes of access to or egress from premises, provided that the said access or egress may only be gained by proceeding over the length of highway specified in the said paragraph, provided that the works being carried out would not be inconveniently interrupted.
- (c) Nothing in Paragraph 1 of this Notice shall apply to any person proceeding in connection with the works in the length or lengths of highway specified in this Notice.
- (d) This Notice is valid for a period of 21 days from the date of this Notice. This Notice may be continued by a further 21-day Notice and/or a Continuation Order (within a maximum period of 6 months).
