This Order is made by the Nottinghamshire County Council under Section 53(2)(b) of the Wildlife & Countryside Act 1981 ("the Act") because it appears to that Authority that the Nottinghamshire Mansfield Area Definitive Map and Statement requires modification in consequence of the occurrence of an event specified in Section (53)(3b) of the Act, namely the expiration of a period such that the enjoyment by the public of the way during the period raises the presumption that the way has been dedicated as a public bridleway over land at Mansfield Woodhouse.

The Authority have consulted with every Local Authority whose area includes land to which the Order relates.

The Nottinghamshire County Council hereby order that:

- 1. For the purposes of this Order the relevant date is 4 June 2021.
- 2. The Nottinghamshire Mansfield Area Definitive Map and Statement shall be modified as described in Part I and Part II of the Schedule and shown on the Map attached to this Order.
- 3. This Order shall take effect on the date it is confirmed and may be cited as "The Nottinghamshire County Council (Mansfield Woodhouse Footpath No. 32 and Bridleway No. 64) Modification Order 2021".
