hereby apply for an order under Section 53(2) of the Wildlife and Countryside Act 1981 modifying the Nottinghamshire Definitive Map and Statement for District of Mansfield and the Derbyshire Definitive Map for the District of Bolsover by

- Adding a bridleway from point **B** on the Derbyshire County boundary, Pleasley to point **C** on the Nottinghamshire County boundary
- Adding a bridleway the point **C** on the County boundary to point **D** on Mansfield FP6
- Adding a bridleway from point **E** at the junction of Mansfield FP6 & FP4 to point **F** on Common Lane, Mansfield Woodhouse
- Upgrading to a bridleway the footpath Mansfield FP27 at from **A** to point **B** on County boundary
- Upgrading to a bridleway the footpath Mansfield FP6 from point **D** to point **E** at the junction of Mansfield FP6 & FP4

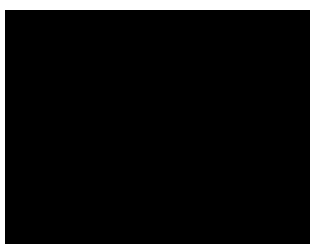

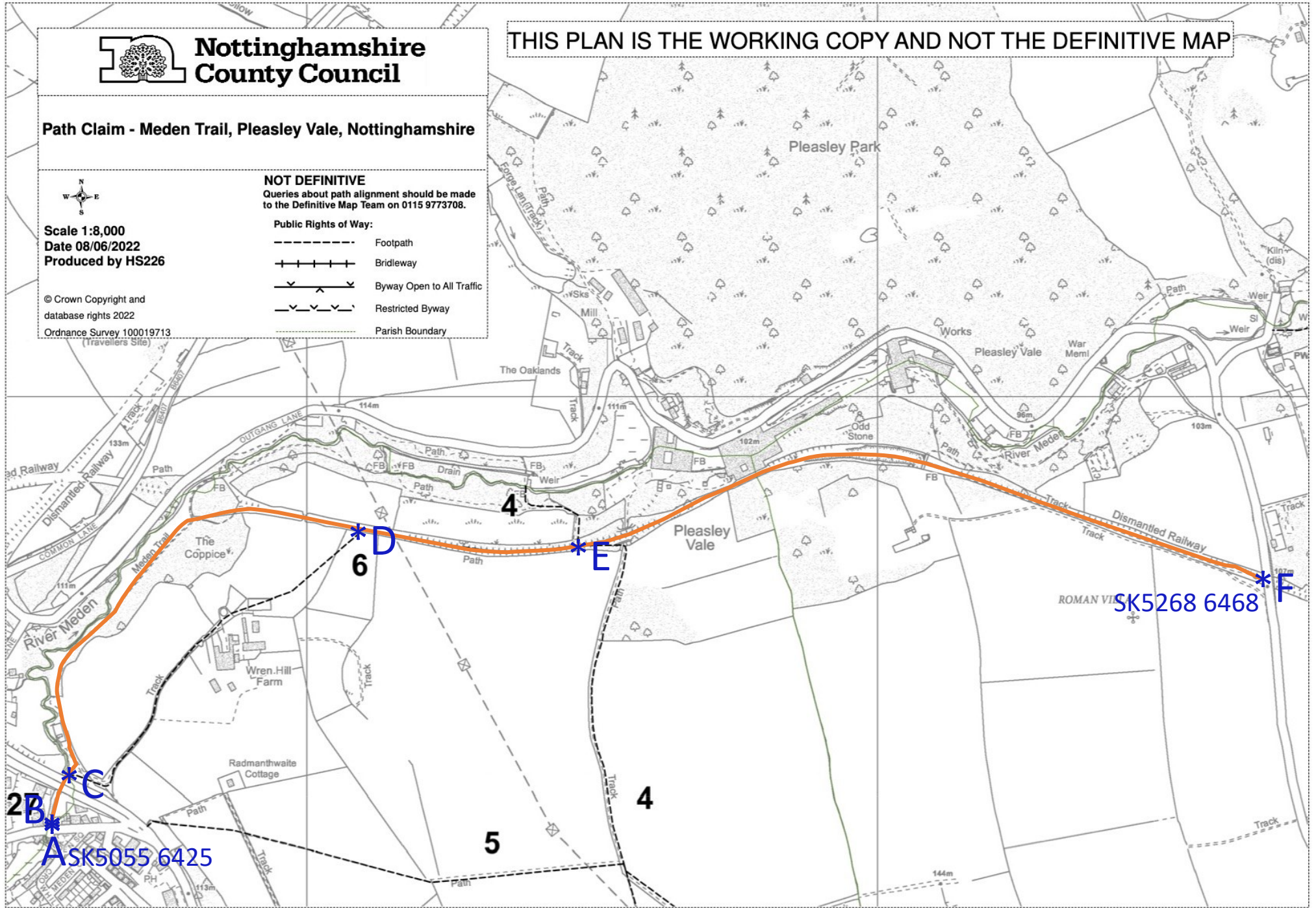
