There is flexibility in all terms on how the full allocation of funded hours can be offered by settings, i.e. where there is a midweek start, there are spare days

at the end of term where the funded entitlement can be used. If any children on your headcount are leaving to start in a school nursery or reception class in September, PVI providers may not claim any funding in Autumn as all the funded hours will be allocated to school. If a parent wishes to use any childcare in a PVI setting before starting school or school nursery, then they can expect to pay the PVI setting rather than use funded hours
