
This Order is made by the Nottinghamshire County Council ("the Authority") under Section 26 of the Highways Act 1980 ("The 1980 Act") because it appears to the Authority that, having regard to the matters set out in Section 26(1), there is a need for a Footpath over the land to which this Order relates, and that it is expedient that the path should be created.

The Ashfield District Council has been consulted as required by Section 26(3) of the 1980 Act.

There shall be at the end of 7 days from the date of confirmation of this Order a footpath over the land at Kirkby in Ashfield described in the Schedule to this Order and shown by a bold broken line on the Map attached to this Order, and thereupon the Nottinghamshire Area 2 Definitive Map and Statement shall be modified accordingly.

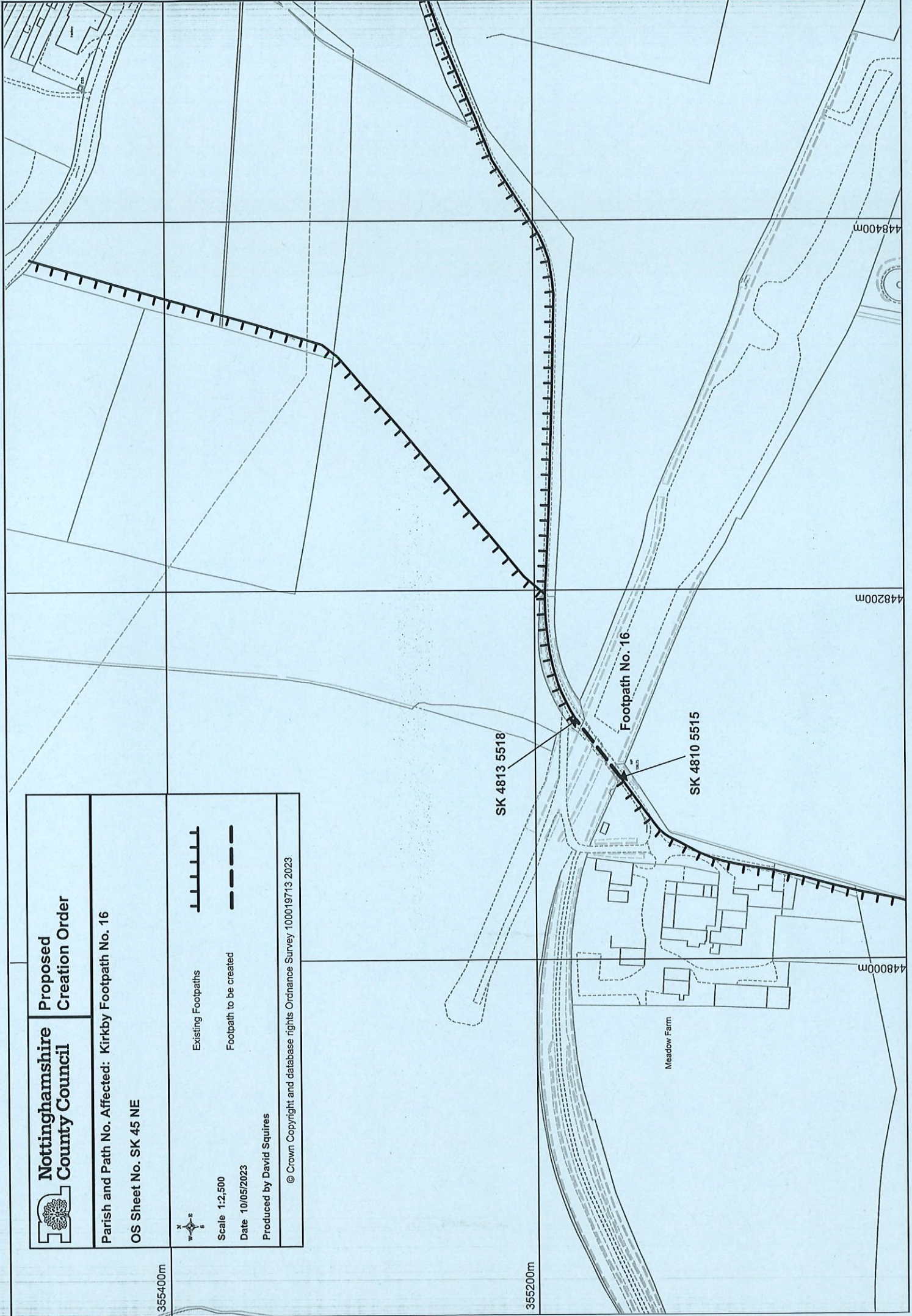

Description of Land

Commencing from a point, SK 4813 5517, at the junction with the north-eastern remainder of Footpath No. 16 and proceeding for a distance of approximately 50 metres in a south-westerly direction, having a width of 1.5 metres and passing beneath three railway bridges to a point, SK 4809 5515, at the junction with the southern remainder of Footpath No. 16.
