### **CENTRAL SCHOOL SERVICES BLOCK FUNDING 2025-26**

## **Purpose of the Report**

1. To seek Early Years & Schools Forum (the Forum) approval to centrally retain funding within the Central School Services Block (CSSB) of the 2025-26 Dedicated Schools Grant (DSG).

### Information and Advice

- 2. The CSSB is funding allocated to LAs to carry out central functions on behalf of pupils in maintained schools and academies in England. CSSB funding is split into two elements: funding for ongoing responsibilities and funding for historic commitments. For 2025/26 Nottinghamshire County Council's allocation is £5.745 million
- 3. The element of funding within CSSB that local authorities receive for historic commitments, made prior to 2013 to 2014, continues to be reduced. In 2025 to 2026 historic commitments funding has been reduced again by 20%.
- 4. For 2025/26 additional funding is being rolled into the CSSB which was provided separately in 2024-25. This relates to funding for centrally employed teachers, through the Teachers' Pension Employer Contribution Grant (TPECG) and the Core Schools Budget Grant (CSBG).
- 5. As prescribed in the DfE's Schools Operational Guide 2025/26; the local authority is required to seek approval from the Forum to centrally retain funding within the Central School Services Block (CSSB) of the DSG. Attached at **Appendix A** to this report is a list of the central budgets the Local Authority is seeking approval to retain.

#### **RECOMMENDATION**

#### That the Forum:

1) Approve the Local Authority's application to centrally retain funding within the Central School Services Block for the services set out at **Appendix A**.
