THE NOTTINGHAMSHIRE (RUSHCLIFFE AREA) DEFINITIVE MAP AND STATEMENT

THE NOTTINGHAMSHIRE COUNTY COUNCIL (WEST BRIDGFORD FOOTPATH NO.6 AND NO.9 & BRIDLEWAY NOS. 68-71) MODIFICATION ORDER 2025

The above Order made on the 9th of July 2025 under Section 53 of the Wildlife and Countryside Act 1981, if confirmed as made, will modify the Definitive Map and Statement for the above Area by adding to thereon: the bridleway (West Bridgford Bridleway No.68) from grid reference SK 5823 3830 at the junction with Trentside and West Bridgford Footpath No.12 proceeding in a generally south-south-westerly direction to SK5819 3817 at the junction with West Bridgford Bridleway No.69, and also by adding the bridleway (West Bridgford Bridleway No.69) from SK 5821 3815 at the junction with Loughborough Road, West Bridgford proceeding in a generally north-westerly then south-south-westerly direction to SK 5800 3765 at the junction with Welbeck Road, West Bridgford, and also by adding the bridleway (West Bridgford Bridleway No.70) from SK 5800 3764 at the junction with Welbeck Road proceeding in a generally west-north-westerly, then south-south-westerly direction to SK 5797 3759 at the junction with West Bridgford Footpath No.6 and West Bridgford Bridleway No.71, and also by upgrading to a bridleway (West Bridgford Bridleway No.71) the public right of way from SK 5797 3759 at the junction with the last mentioned Bridleway No.70 and West Bridgford Footpath No.6 proceeding in a west-south-westerly, then westerly direction to SK 5744 3749 at the junction with West Bridgford Footpath No.9 then continuing in a generally north-westerly direction to SK 5701 3773 at the junction with Coronation Avenue/tramway at Wilford, and also by varying the particulars to the West Bridgford Footpaths No.6 and No.9, all as described in the Order and shown on the order map.

Any representations about or objections to the Order must be received by the Countryside Access Team at the address given below not later than the 9th of September 2025. Please state the grounds on which they are made.

If no such representations or objections are duly made to the Order, or any part of it, or if any so made are withdrawn, the Nottinghamshire County Council, instead of submitting the Order to the Secretary of State (or part of it if the Authority has by notice to the Secretary of State so elected under Paragraph 5 of Schedule 15 to the Wildlife & Countryside Act 1981) may itself confirm the Order (or that part of the Order) as an unopposed Order. If the Order is submitted to the Secretary of State for the Environment, (in whole or in part), any representations or objections which have been duly made and not withdrawn will be sent with it.
