

# Referral to Fair Access

Each local authority **must** have a Fair Access Protocol to ensure that unplaced and vulnerable children, and those who are having difficulty in securing a school place in-year, are allocated a school place as quickly as possible.

Nottinghamshire County Council has a well-established Fair Access Protocol and works in partnership with schools, parents, and carers to ensure that unplaced children and those in vulnerable circumstances are allocated a school place quickly.

The majority of In Year applications are dealt with promptly. For a small number it may be necessary to refer to the Fair Access.

**Your child is without a school place** – If, after applying for a school place through the normal in year process, your child remains without a school place within a reasonable distance. Your case will then be referred to Fair Access for review and possible action.

**Referral under paragraph 3.10 of the School Admissions Code 2021** – A school to which an application has been made has indicated that they do not wish to admit a child because it has good reason to believe that the child may display challenging behaviour. This is because the school has a particularly high proportion of children with challenging behaviour or previously excluded children and the admission authority believes that to admit a further child with challenging behaviour into that year group will prejudice the provision of efficient education or efficient use of resources.

The Fair Access team will work with the school to ensure that any refusal made is in line with the School Admissions Code and, that where a refusal is agreed, support is given to secure ongoing access to education for the child concerned.

## What will happen now?

The Fair Access team will now review your case and a member of the team will be responsible for ensuring progress. This may include contacting you to discuss next steps, speaking to the school(s) involved, gathering further information and referral to a locality panel where decisions are made regarding children requiring a school place and unresolved applications. The panel of schools considers all information provided and will carefully review several factors including:

- whether your child has access to a school place;
- relevant information about any additional support your child may require in school;
- information provided by the school relating to any existing pressures within the year group;
- the most appropriate education pathway for your child.

If your child is without a school place, the panel will be required to identify an education pathway. This could include an offer of a school place that is in a school to which you did not make an application.

### **Remember:**

Where possible your child should continue to attend their current school until an admission date has been agreed.

You will be informed in writing of the outcome of any decisions. If your child resides within Nottinghamshire and remains without a school place, Nottinghamshire County Council will continue to support you and your child to ensure that appropriate education provision is made.

## Right of Appeal

If you have been refused a place at your preferred school, you have the right to appeal against the decision. If you do wish to appeal, you will need to set out the grounds in writing. Admission authorities publish appeals timelines on their websites, but any appeals submitted after the deadline must still be heard.

Academies, foundation schools, free schools and voluntary aided schools are responsible for arranging their own appeals. You should contact the school directly to find out how to appeal.

Ahead of the appeal hearing, you will be sent full details of how the admission arrangements and coordinated scheme applied to your application. This will include reasons for the decision to refuse the application and an explanation of how the admission of an additional child would cause prejudice to the provision of efficient education or efficient use of resources.

## Transport to school

If your child is attending full time statutory education at the catchment or nearest available school and you live over the statutory walking distance, your child may be eligible for free home to school transport or travel assistance.

You are responsible for getting your child to school and applying for transport if you think you are eligible.
