Delete the footpath known as Greasley Footpath 40 running from Point (A): Junction with F.P.32 north of Black Bull Inn [SK 4838 4636] to Point (B): Main St. Newthorpe, opposite house No. 152 [SK 4824 4656] along its full length and width and marked on the attached map with the red line.
